# Cancellation Policy NLSDays 2026, 8th-9th September

#### Individual Registration Cancellation

Registration cancellations must be sent by 30<sup>th</sup> April 2026 to SwedenBIO Service AB at <a href="mailto:nlsdays.sales@swedenbio.se">nlsdays.sales@swedenbio.se</a> to receive a refund (minus a EUR 200 ex. VAT processing fee).

- Cancellations received from 1<sup>st</sup> May and until 30<sup>th</sup> June 2026 are eligible for a 50% refund of the paid registration fees only.
- Cancellations received from 1<sup>st</sup> July 2026 are not eligible for any refund.
- Presentation fees are not eligible for any refund.

Any eligible refunds will be processed after the event by credit card refund or bank transfer. Please note that no-shows will be billed for the full registration and/or presentation fees.

#### Payment options

Master Card, Visa and AMEX (online credit card payments):

New registrants will receive their final invoice over email right after their registration payment is completed.

### Trustly (online bank transfer payment):

New registrants will receive their final invoice over email right after their registration payment is completed.

#### Regular Bank Transfer

New registrants will receive a proforma invoice including our bank details shortly after their registration. To guarantee the rate applied while registering, the invoice must be paid by **the next 2 weeks** upon proforma reception. Final invoice will be automatically sent over email after payment completion.

## Replacement

#### Exhibition/Sponsorship packages Cancellation

Cancellation must be received in writing from the primary contact on file. Signed exhibition/sponsorship booking will be immediately financially liable for a 25% cancellation fee until 31st March 2026, for a 50% cancellation fee from 1st April until 31st May 2026 and for a 100% cancellation fee from 1st June 2026.

#### Force Majeure

Where a Force Majeure Event has or may have an adverse impact on the ability of SwedenBIO to arrange the Event at the planned venue or on the planned date, then SwedenBIO shall be entitled but not obliged to either provide an alternative format, facility or venue for the Event and/or reschedule the Event.

If SwedenBIO is unable to rearrange or reschedule the Event pursuant to this condition, then you will be entitled, in your sole discretion, to receive either a refund or credit note in respect of your fees received by SwedenBIO.
